The Council, Councillors, ratepayers and residents would also now be well aware that the Zig Zag Railway closed its operations on the 17 June 2012.

Whilst the future of the Zig Zag Railway is now very much in doubt, the asset is of such historical, heritage and tourism significance that it demands the Lithgow Council should take up the leadership on the matter and that the Council should hold an urgent public Summit involving all stakeholders to discuss the future of our major Tourist Attraction.
