ITEM 3: BUSINESS ARISING FROM THE MINUTES

1. BUS SHELTER - MID-TOWN FUELS, MAIN STREET

It has been noted that large numbers of students congregate outside the Mid-Town Fuels on Main Street, Lithgow. Students are waiting for the school bus and congregating around the fuel pumps and moving vehicles. It is suggested that a bus shelter be installed in the vicinity in consultation with the bus company and owner of the petrol station.

ITEM 4: RESTRICTED PARKING SPACE WILLIWA STREET PORTLAND

Correspondence has been received in regards to the creation of a restricted parking space fronting 43 Williwa Street Portland. As many elderly people frequent this area it is asked that a parking space to allow better access for patrons of the Sister Mary O'Leary Centre and St Vincent de Paul. Following from the previous TALC meeting the location of the disabled parking area has been identified as in front of the St Vincent de Paul with the current steps to be at the rear of the disabled parking bay. ITEM 6: TRAFFIC MANAGEMENT CONCERNS

Correspondence has been received from the Environment and Development Department of Council regarding the traffic flowing out of Lithgow High School from Pau Street. After investigating amendments to property addresses in the area it was brought to Council's attention by landowners that during school hours road users "cut the corner" of Bridge Street heading into Eskbank Street. It is requested that a small median or a roundabout at the intersection be installed in place of the existing concrete island in order to encourage traffic to take wider turns. It is noted that traffic data for the last 5 years has been analysed and no accidents have occurred in the vicinity during this time. See Attachment 7.

ITEM 7: DISABILITY ACCESS COMMITTEE - LANEWAY BEHIND COUNCIL

Correspondence has been received from the Disability Access Committee regarding some issues with the laneway behind Council's building and the parking area between Eskbank Street and Cook Street. Please note that upon the completion of a site inspection, it has been noted that 'No Parking' and 'No Stopping' signage is inconsistent along the stretch of Mort Street Lane and some of the existing signage is illegibly faded. Also, there is no 'Give Way' sign on the eastern side of Mort Street Lane while there is a sign on the west side. See Attachment 8.

THAT Council conduct a review of the No Parking Signage in the lanes between Bridge Street and Burns Lane running east to west and rectify any deficiencies or anomalies in the existing signage.
