**COMMENTARY**

Correspondence has been received from Tanderra Nursing Home in relation to the local government election.

The Director of Nursing wished to place a complaint on behalf of the residents and their families of Tanderra Nursing Home. They were of the understanding the Australian Electoral Commission (AEC) had representatives at their neighbouring Residential Aged Care Facility (Cooinda) on Tuesday 9<sup>th</sup> September 2008.

Tanderra is home to forty seven residents in our community and their right to vote has not been facilitated in any way by the AEC. Understandably this has angered and upset many of the residents and their families.

On Wednesday 10<sup>th</sup> September 2008, the Director of Nursing made enquiries to the Returning Officer, Mr Andrew Frater who informed the Director that Tanderra was not a "Declared Institution" and therefore residents would not be visited by AEC representatives to facilitate their voting rights, despite the verbal objection from the Director of Nursing. The Director was advised that it was too late for the residents to vote in this election.

The Director of Nursing is appalled by the decision to classify Tanderra as "Not a declared institution". Who makes these decisions? Additionally as part of the Aged Care Standards and Accreditation Agency it is an *"expected outcome that residents participate in the life of the community within and outside the residential care serve"*. As the Manager of the facility, it is the Directors duty to ensure residents maintain their individual rights.

The Director of Nursing advised that despite the fact that all the residents are "high care" many still have an interest in their community and also possess the cognitive skills required to make decision such as voting, however their right to vote in this election has been neglected by the AEC.

**SUMMARY**

This report recommends amendments to the Council’s Code of Meeting Practice, version 6, as adopted by the Council on 21 April 2008.

**COMMENTARY**

All policies of Council must be reconsidered within 12 months of a general election. It is proposed that Council’s policies will be submitted to the Council for consideration over a staged period of time.

As there are 5 new elected Councillors, the Council’s Code of Meeting Practice, version 7, is tabled at the Policy and Strategy Committee meeting for consideration.

However, adoption of the Council’s Code of Meeting Practice, version 7, will be deferred to the Ordinary Meeting of the Council on Tuesday 21 October 2008 as the adoption of the Code of Meeting Practice is a function delegated to the Ordinary Meeting of the Council.

The following changes are proposed to create version 7. These changes have been highlighted in the attached Code of Meeting Practice version 7.

### **LEGAL IMPLICATIONS**

The Local Government Act 1993 states:

Section 360 – *“Conduct of meetings of councils and committees*

- (1) The regulations may make provision with respect to the conduct of meetings of councils and committees of councils of which all the members are councillors.
- (2) A council may adopt a code of meeting practice that incorporates the regulations made for the purposes of this section and supplements those regulations with provisions that are not inconsistent with them.
- (3) A council and a committee of the council of which all the members are councillors must conduct its meetings in accordance with the code of meeting practice adopted by it.”

Section 362 - *“Adoption of draft code*

- (2) If the Council decides to amend its draft code, it may publically exhibit amended draft in accordance with this Division or, if the council is of the opinion that the amendments are not substantial, it may adopt the amended draft code without public exhibition as its code of meeting practice.”

Note: Should the Council make substantial changes to the Code, the Council would need to allow, under section 361 of the Act *“a period of not less than 42 days after the date on which the draft code is placed on public exhibition during which submissions may be made to the council”*.

It is considered that the above proposed changes to Council’s Code of Meeting Practice are not substantial and thus do not require public exhibition.

### **REFERENCE**

### **SUMMARY**

To advise of the receipt of expressions of interest submissions for the proposed capital works at the Crystal Theatre and recommend that the selected contractors be invited to tender for the project.

### **COMMENTARY**

As previously resolved by council expressions of interest were called for the proposed improvements at the Crystal Theatre, Portland. Advertisements were placed in the Lithgow Mercury and the Sydney Morning Herald. A total of six (6) expressions of interest were received from the following:

- Barker Construction Services, Gladesville.
- Tablelands Builders, Bathurst.
- M.Bruton Building Company, Annangrove.
- C&M Construction Group, Parramatta.
- CBS Refurbishment, Rydalmere.
- Uniport, Mulgrave.

Examination of the expression of interest submissions from each company reveals that they have met the criteria for acceptance of the documentation. Council has previously worked with Barker Construction Services on the Lithgow Library Learning Centre, and M.Bruton Building Company who constructed the caretakers residence at Lake Wallace. The other companies are not known to council but the documentation provided indicates that they have the capabilities to complete the contract and could be requested to tender.

It is noted that no submissions were made by local builders.

Councils Tendering Policy requires that Council consider a report from the assessment team with a recommendation to proceed to the tender process for selected tenderers pursuant to the provisions of Section 55 of the Local Government Act, 1993, and Clause 166 of the Local Government (General) Regulation 2005.

#### REPORT FROM: MANAGER COMMUNITY AND CULTURE – MATTHEW JOHNSON

#### REFERENCE

Matter Arising PO8-96 – Policy and Strategy Committee Meeting 5 August 2008

#### SUMMARY

At the Policy and Strategy Committee meeting of 5 August 2008, Councillor Fisher moved a Matter Arising in relation to a new Aboriginal Committee who wished to have a meeting with the new General Manager and Council Officers to discuss various issues. Councillor Fisher requested that a meeting be arranged in due course.

#### COMMENTARY

Council has received correspondence from the newly formed organisation called Mingaan Aboriginal Corporation. Members of the organisation are from the Wiradjuri tribe which extends from the bottom of Mt Victoria Pass to Dubbo and Wagga Wagga. Members of Mingaan also met recently with the Mayor and Acting General Manager to discuss a number of matters including those outlined in the attached letter.

The major points in Mingaan's letter are:

- To advise Council of the group's formation.
- To advise Council that Blackfellows Hands Cave Reserve has been declared an Aboriginal Place by the National Parks and Wildlife Service and that an invitation will be sent to Councillors to a celebration on 16 November 2008.
- That Mingaan has, in partnership with three other Aboriginal Communities, formed an agreement with Emirates for the development of cultural activities at the Wolgan Valley Resort.
- To ask if Council has funds specifically for Aboriginal and Torres Strait Islander cultural activities.  
(Note: *Mingaan will be provided with an application form for Council's Community Donations program.*)
- To ask if Council has office space from which Mingaan can operate at a nominal rent.  
(Note: *Council does not have any such space however Mingaan will be advised to contact local organisations including Lithgow Information and Neighbourhood Centre, LINC, for this purpose.*)

Mingaan also raised a number of matters at the meeting with the Mayor and Acting General Manager:

- Some concerns were expressed about the impact on Aboriginal heritage from the works recently undertaken at Hyde Park Hartley. It was explained to Mingaan members at the meeting that prior to works commencing Council undertook an extensive consultation process with local Aboriginal groups and a detailed Heritage Assessment was undertaken by the Australian Museum.

Works were undertaken in accordance with the Heritage Assessment and with the agreement of the Aboriginal groups consulted. Further, that no Aboriginal artefacts were removed from the site and the major purpose of the works had been to remediate the effects of many years of un-restricted recreational use, to manage future recreational use and to preserve the Aboriginal heritage values of the site.

- Mingaan are interested in developing a consultation protocol with Council for use in the future.

It is considered that the development of such a protocol would be beneficial for future consultation processes with the Aboriginal community. It is recommended that the development of such a process be widely advertised to provide all Aboriginal communities and individuals the opportunity to be involved.
